## Categories and Qualifications

**The Little Miss Ozark Pageant and Miss Ozark Pageant are National Peanut Preliminary Pageants and are CLOSED Pageants. Future Little Miss Ozark, Petite Miss Ozark, Junior Miss Ozark and Teen Miss Ozark are OPEN Pageants.**

### Future Little Miss Ozark Pageant Qualifications

Contestants must be between the ages of 4-5 years old and not eligible for Little Miss Ozark.

Contestants cannot hold the title of Future Little Miss Ozark and the title in another town or city at the same time.

### Little Miss Ozark Pageant Qualifications

Contestants must be in the first grade and eligible to enter the second grade for the 2019-2020 school year.

Contestants must be at least 6 years old but not more than 8 years old by the date of the National Peanut Festival Pageant (October 12, 2019).

Contestants must be a student at an Ozark City School or have an Ozark, Alabama address verifiable by the United States Postal Service.

Contestants cannot hold the title of Little Miss Ozark and the title in another city or town at the same time.

Contestants must agree to represent the city of Ozark in the National Peanut Festival Pageant to be held in October 2019.

### Petite Miss Ozark Pageant Qualifications

Contestants must be between the ages of 8-11 years old.

Contestants cannot hold the title of Petite Miss Ozark and the title in another city or town at the same time.

### Junior Miss Ozark Pageant Qualifications

Contestants must be between the ages of 12-14 years old.

Contestants cannot hold the title of Junior Miss Ozark and the title in another city or town at the same time.

### Teen Miss Ozark Pageant Qualifications

Contestants must be in the 9<sup>th</sup> or 10<sup>th</sup> Grade and not eligible for the title of Miss Ozark.

Contestants cannot hold the title of Teen Miss Ozark and the title in another city or town at the same time.

### Miss Ozark Pageant Qualifications

Contestants must be at least seventeen (17) but not over twenty-one (21) years of age on the date of the National Peanut Festival Pageant Preliminaries (October 18, 2019).

Contestants must be of good moral character, single, never married and must not be pregnant or ever had a pregnancy.

Contestants must agree to represent the city of Ozark in the National Peanut Festival Pageant to be held in the fall of 2019.

Contestants cannot hold the title of Miss Ozark and the title of another town or city at the same time.

Contestants must be a student in an Ozark City School or have an Ozark address verifiable by the USPS.
